Artist in Residence program. Question: How is the artist in residency program going? Alex Cosmos has been in residence and the program will be advertised. Currently talking applications including from writers.

Deed of grant (Trevor Heldt)

Strathanirn submitted a 5 year funding proposal and received approval for 2 years with a further 3 after meeting criteria. These are delivering the program that was proposed, meeting the 9 measures and some special requirements set by artsACT. The organisation will need to move to a modern management model. The Board has commenced a 4 step process over the next 8 months to ensure Strathnairn is in a good position to continue funding. Engagement with members and artsACT will be iterative. The 4 steps are:

- Understanding the requirements
- Developing options
- Selection of preferred option
- Implementation

The Board will hold a planning meeting in July.

Liz Coats met with artsACT staff member and encouraged her to visit Strathnairn.

Barbie Robinson suggested an inclusion an interview in the contract for exhibiting artists.

Licence (James Holland)

The new licence from artsACT has not been finalised. However, James confirmed we will be able to provide some more certainty shortly. James will be meeting with artists individually over the next four weeks to discuss longer licences.

Anita McIntyre encouraged collaboration with other ACT organisations.

Studio Question: How many applications are on the books? There are 7 applications on the waiting list. We would like to capitalise on the breath of artists at Strathnairn as a unique arts organisation.

Neil Cobbran commented that modern management is a new permutation of corporate planning and performance management. Neil has suggested that his skill set could be suitable for a nomination on the board and will follow up with the Board following the meeting.

Use of land & development

Margaret Gordon asked about the building that is to be handed over. James advised the handover was scheduled for 2025.

Liz Coats suggested Strathnairn could be used as a nature reserve.
